#### BACKGROUND

At the last Council Meeting it was resolved:

FURTHER that the General Manager report on the positive aspects of continuing Gwydir's membership in Namoi Unlimited to the next meeting.

#### COMMENT

A formal proposal has now been received from the New England Joint Organisation and a copy is attached.

This report recommends that the Council becomes an Associate Member of the New England Joint Organisation (NEJO). There are many areas where the close co-operation with the NEJO is beneficial to this Council. Obviously that

relationship already exists to a large extent but becoming an Associate Member will further cement this relationship.

With regard to the second part of the Council's resolution, documentation is tabled to provide some background to the current operation of the Namoi Joint Organisation, Namoi Unlimited. Also included is the most recent Members' Value Report.

During the recent budget discussions the members of the Namoi JO have agreed that next year's membership fee will be increased by only the 2.6% rate pegging allowance rather than the substantial increase being considered.

The potential for significant annual membership dues was an area of concern to this Council. The current annual contribution, objectively, is relatively minor when you measure it against the tangible outcomes already received and the current planning work underway which should result in additional savings greater than the annual fee.

Certainly, due to Gwydir's geographical location, some of the Namoi Unlimited member councils benefit more greatly than does Gwydir from the alliance. However, Gwydir has benefitted from its association especially in the areas of water management, training and regional advocacy.

The tabled Charter outlines the principal functions of Namoi Unlimited as:

- establish strategic regional priorities for the joint organisation area and develop strategies and plans for delivering these priorities
- provide regional leadership for the joint organisation area and to be an advocate for strategic regional priorities
- identify and take up opportunities for intergovernmental cooperation on matters relating to the joint organisation area.

I believe that Namoi Unlimited is achieving its Charter.

At the moment the General Managers' Namoi group called JOLT is developing several proposals that will result in savings and/or benefits to the member councils and the communities they serve.

Two of these are in the final stages of planning and are the collective Internal Audit Function and the development of the local vendor panel. Hopefully these proposals will be finalised over the next year.

Other possible service sharing options are also being reviewed but, quite rightly, each Council is keen to maintain its existing employment numbers because of its importance to its local economies.

The down side of the Council's membership is the current over-reliance on the onerous meeting schedule for both JOLT and the Board with monthly meetings. In spite of Gwydir's efforts to minimise the meeting cycle there is resistance among some member Councils to rationalize the meeting cycle. We live in hope!

At a recent webinar conducted by the Minister for Local Government there was a strong indication that no Councils will be allowed to opt-out of any Joint Organisation for at least the next two years as these Organisations may have a significant role to play as the local government sector recovers for the Covid 19 pandemic.

### CONCLUSION

The outcome being recommended in this report is to take up the offer of an Associate Membership with the New England Joint Organisation and maintain the Council's membership in the Namoi Joint Organisation with a review in October 2021.

Gwydir's position has consistently been that the Namoi and New England Joint Organisations should merge. Hopefully Gwydir can become an honest broker and move this dream forward although there would need to be some personality changes to occur for it to become a reality.

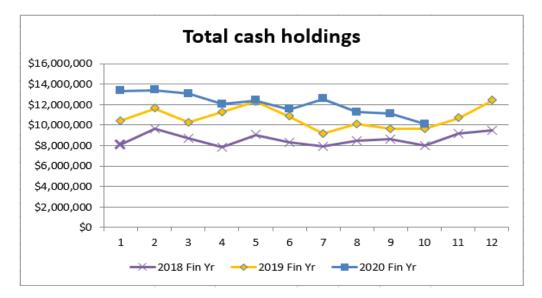

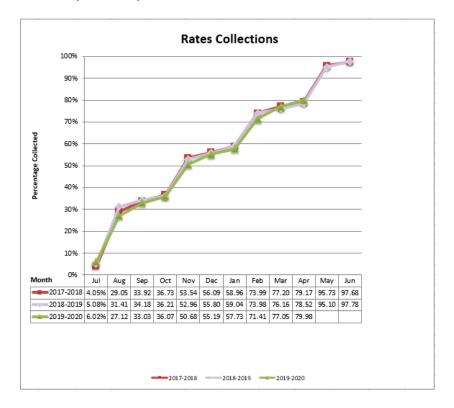

#### BACKGROUND

On 22 May 2020 the Australian Government announced a new \$500 million Local Roads and Community Infrastructure Program (LRCI Program).

The funding allocations have been calculated in a similar way to how the Roads to Recovery Program and the road component of the Financial Assistance Grants works.

This formula takes into consideration road length and population and is based on recommendations of Local Government Grants Commissions.

Gwydir Shire has been advised that and allocation of \$1,182,224 under the newly created Local Road and Community Infrastructure Program.

This program will allow the funding to be spent on roads or other projects such as "new or upgraded bicycle and walking paths, community facilities, and picnic shelters and barbeque facilities at parks".

The Federal Government's website states "*This program will support local* councils to deliver priority local road and community infrastructure projects across Australia, supporting jobs and the resilience of local economies to help communities bounce back from the COVID-19 pandemic".

The commencement of the sealing of the Horton Road between Upper Horton and Killarney Gap Road, also the subject of a NSW Government Fixing Local Roads Grant but undetermined as yet;

The upgrade of the Warialda Medical Centre (approximately \$200,000) but its ability to be included would need to be established under the program guidelines; and;

Smaller projects across the Shire such as some requested work at the Presbyterian Church in Warialda or the Anglican Church at Upper Horton.

A full list of possible projects will be presented to Council for consideration. The funding is available from 1<sup>st</sup> July 2020.

New program delivers \$21m for Parkes electorate councils

22 May 2020

Councils in the Parkes electorate will be supported with more than \$21 million in new funding, as part of the Federal Liberal and Nationals Government's \$1.8 billion boost for road and community projects through local governments across Australia.

The investment will support local jobs and businesses, and boost local economies struggling with the effects of COVID-19.

Federal Member for Parkes and Minister for Local Government Mark Coulton said the package included the establishment of a new \$500 million Local Road and Community Infrastructure Program, and the bringing forward of \$1.3 billion of the 2020-21 Financial Assistance Grant payment.

The new Program is based on the successful Roads to Recovery program and will enable local councils to deliver priority projects with a focus on upgrades and maintenance to local roads and community infrastructure.

Mr Coulton said accelerating local infrastructure projects was important for supporting jobs and the local economy in the Parkes electorate.

"Every single job we support makes a huge difference in our local communities, now and as we navigate out of the coronavirus pandemic," Mr Coulton said.

"Not only will this package support jobs, construction businesses and the economy across the region, it will improve our local roads, and provide for new and upgraded amenities to help communities stay connected.

"I will be working alongside all Parkes electorate councils to make sure projects get underway to support jobs and businesses as soon as possible."

Local road projects to be delivered under the Program include, but are not limited to, constructing or improving bridges and tunnels, street lighting, and heavy vehicle facilities such as rest areas.

A broad range of community infrastructure projects will be eligible including new or upgraded bicycle and walking paths, community facilities, and picnic shelters and barbeque facilities at parks.

Mr Coulton said that under the Financial Assistance Grant program, more than \$55 million in payments had been made to councils in the Parkes electorate this financial year. This

#### \$11.8 MILLION IMMEDIATE INVESTMENT FOR LOCAL COUNCILS IN NEW ENGLAND

Councils in the New England will receive more than \$11 million in Australian Government funding to build new road and community projects throughout the electorate.

Federal Member for New England, Barnaby Joyce, said the direct investment to local governments will support local jobs and businesses and boost local economies struggling under the effects of COVID-19.

The package included the establishment of a new \$500 million Local Road and Community Infrastructure Program and the bringing forward of \$1.3 billion of the 2020-21 Financial Assistance Grant payment.

Mr Joyce said accelerating local infrastructure projects was important for supporting jobs and the local economy in the New England.

"Every single job we support makes a huge difference in our local communities, now and as we navigate out of the coronavirus pandemic," Mr Joyce said.

"Not only will this package support jobs, construction businesses and the economy across our New England electorate, it will improve our local roads and provide for new and upgraded amenities to help communities stay connected.

"I will be working closely with councils to make sure projects get under way to support jobs and businesses as soon as possible."

The new Program is based on the successful Roads to Recovery program and will enable local councils to deliver priority projects with a focus on upgrades and maintenance to local roads and community infrastructure.

Local road projects to be delivered under the Program include but are not limited to constructing or improving bridges and tunnels, street lighting, and heavy vehicle facilities such as rest areas.

A broad range of community infrastructure projects will be eligible including new or upgraded bicycle and walking paths, community facilities, and picnic shelters and barbeque facilities at parks.

Guidelines for the Program will be provided directly to local governments by the Department of Infrastructure, Transport, Regional Development and Communications.

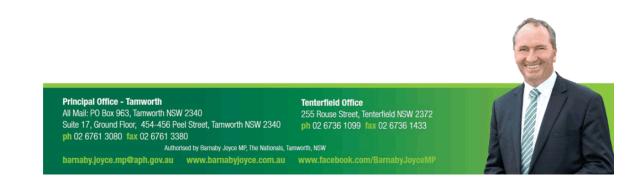

Local Roads and Community Infrastructure Program

As the closest tier of government to the community, local governments have a critical role in delivering vital services and ensuring the quality of life for communities across Australia. Local governments are now also playing a key role in protecting the community from the impacts of COVID-19.

The Australian Government has committed \$500 million to the Local Road and Community Infrastructure Program (LRCI Program) to support jobs, businesses and the resilience of local economies.

From 1 July 2020, councils will be able to access funding to support delivery of priority local road and community infrastructure projects.

#### Who will receive funding?

All local councils will be eligible for funding under the LRCI Program.

State governments and the shires of Christmas Island, Cocos (Keeling) Islands and Norfolk Island and the Lord Howe Island Board that deliver council services to unincorporated areas in their jurisdiction will also be eligible for funding.

In addition, the Northern Territory Government will be eligible for funding for roads in areas which until 2008 were unincorporated and for which responsibility has not been transferred to relevant councils.

#### How much funding will each council receive?

Each council will receive a share of funding under the Local Roads and Community Infrastructure Program (see *Local Roads and Community Infrastructure Program: Funding Allocations*).

A council's share of funding has been calculated in a similar way to how the Roads to Recovery Program and the road component of the Financial Assistance Grants works. This formula takes into consideration road length and population and is based on recommendations of Local Government Grants Commissions.

#### How can councils apply for funding?

Councils will be able to select the projects to be funded in their community according to priorities at the local level.

Similar to the Roads to Recovery Program, councils will need to submit a Work Schedule that outlines the project(s) they plan to undertake.

As long as these projects are eligible local road or community infrastructure projects, they will receive funding.

#### What projects will be eligible for funding?

Funding is available for local road and community infrastructure projects that involve the construction, maintenance and/or improvements to council-owned assets (including natural assets) that are generally accessible to the public.

Projects will need to deliver benefits to the community, such as improved accessibility, visual amenity and safety benefits.

Eligible local road projects could include works involving any of the following associated with a road:

- traffic signs;
- traffic control equipment;
- street lighting equipment;
- a bridge or tunnel;
- a facility off the road used by heavy vehicles in connection with travel on the road (for example, a rest area or weigh station);
- facilities off the road that support the visitor economy; and
- road and sidewalk maintenance, where additional to normal capital works schedules.

Eligible community infrastructure projects could include works involving:

- Closed Circuit TV (CCTV);
- bicycle and walking paths;
- painting or improvements to community facilities;
- repairing and replacing fencing;
- improved accessibility of community facilities and areas;
- landscaping improvements, such as tree planting and beautification of roundabouts;
- picnic shelters or barbeque facilities at community parks;
- playgrounds and skateparks (including all ability playgrounds);
- noise and vibration mitigation measures; and
- off-road car parks (such as those at sporting grounds or parks).

#### When will funding be available?

Funding will be available from 1 July 2020.

#### Are there any conditions that apply to funding?

Councils will need to complete all project works by 30 June 2021 to receive their full nominal share of funding.

Councils will also need to demonstrate that projects are additional to their pre-COVID-19 work program for 2020-21. If a project has been brought forward from a future work program it will be eligible for funding.

Additional conditions, such as signage requirements, will be outlined in program guidelines, which are currently being finalised.

#### What are the next steps?

The Department of Infrastructure, Transport, Regional Development and Communications will be consulting with local government organisations to finalise implementation arrangements for the LRCI Program.

Councils will then be asked to agree to the program arrangements and identify local projects in their area.

### Warialda Fire Break (Ref: 118/20)

The following response from the Rural Fire Service Commissioner to The Hon Adam Marshall MP was discussed:

Please see below actions that have been taken with regards to Warialda.

- NSW RFS have completed inspections throughout the interface and outskirts surrounding Warialda.
- 12 duty of care hazard complaints are being actioned after these inspections. Four of these will be resolved through asset protection zone (APZ) works with the remaining eight subject to hazard reduction burning.
- Local NSW RFS staff have met with NPWS, Crown Lands, Local Lands Services and Council representatives to determine immediate and ongoing actions.
- Local NSW RFS staff will meet with FCNSW personnel next week.
- Ten hazard reductions ranging from 1 to 15 ha are planned for this year as conditions allow, hazard reduction certificates and burn plans are being finalised.
- NSW RFS mitigation crews have been working to clear APZs' and containment lines for the past two weeks, it is expected these works will be completed this week.
- Gwydir council has completed APZ works on several parcels of council land over the past fortnight.
- Local NSW RFS staff in consultation with the land managers have developed a proposal to implement an ongoing mosaic burn program across 78 blocks over next seven years.
- The NSW RFS Namoi Gwydir District Manager is liaising with council regarding ongoing representation of a NSW RFS staff member on the Gwydir Council Bush Fire Committee which operates alongside the BFMC.
- We have confirmed a hazard reduction in 2018 burnt approx. 75ha on the southern edge of the township.

### Hope this helps allay concerns

The consensus view of the meeting was that the response fell well short of the outcome that the Council is seeking. Warialda is very much under threat if an adequate fire break strategy is not put into place along the lines of that proposed in the SMK Strategy referred to the RFS and that this be conveyed to the Shire's Local State Member.
