Section 3 – Conditions

In order for Council to support your application to the North West Local Land Services (NWLLS) for a permit to graze stock on Council's roads, the following conditions are to be included in permits issued by the NWLLS in addition to the standard conditions required by the NWLLS. The Applicant must comply with following conditions and provide the following information to Council:

- 1. That grazing is only permitted along the frontage of the Applicant's property.
- Concurrence will only be issued for the maximum period of 30 days 2.
- 3. Stock is only permitted to be grazed during daylight hours.
- 4. A "responsible" person is to be present at all times, unless and electric fence is erected to contain stock off the road surface.
- 5. Prescribed signs are erected and placed in prominent positions to enable road users to be warned of the grazing activities.
- 6. If the Applicant is not the adjoining owner, that it be a condition of the permission to graze a road reserve, that the person requesting grazing rights receive the consent of the adjoining owners.
- 7. The Applicant must hold a Public Liability Insurance Policy with a minimum of \$20 Million to cover this activity, and that a copy must be provided to Council prior to the granting of the concurrence.
