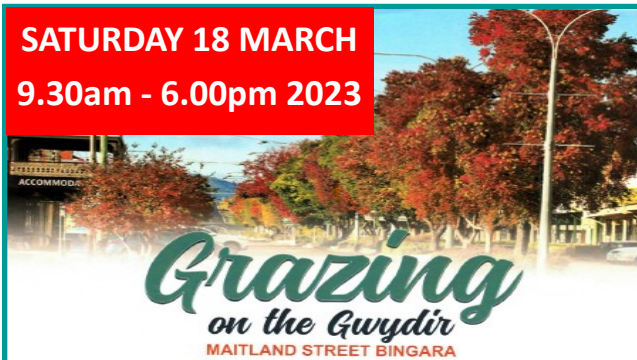
There is usually no limit on morning stalls however afternoon spaces are limited and determined by selection.

WORKING WITH CHILDREN: If stallholders are working with children a declaration must be completed and submitted with this application.

STALL HOLDERS: must bring own table, chair, and shade plus extension cord if required.

All extension cords must show current tag and testing.

SITE SET UP: Stallholders must set up their display/stall in a safe work manner.
No setup on roadway or set up is not to impede traffic.

VEHICLE MOVEMENT: The committee recommend that you complete your set up, then move your vehicle to the designated parking area prior to Event commencement.

RISK ASSESSMENT: Stallholders must abide by any direction given to them by the Committee in relation to risk management.

WORK HEALTH & SAFETY - It is a requirement that all stallholders comply with the current Work Health and Safety legislation.

FOOD SERVICE OPERATORS – It is a requirement that food service operators are to comply with food safety standards and supply all applicable forms with this application.

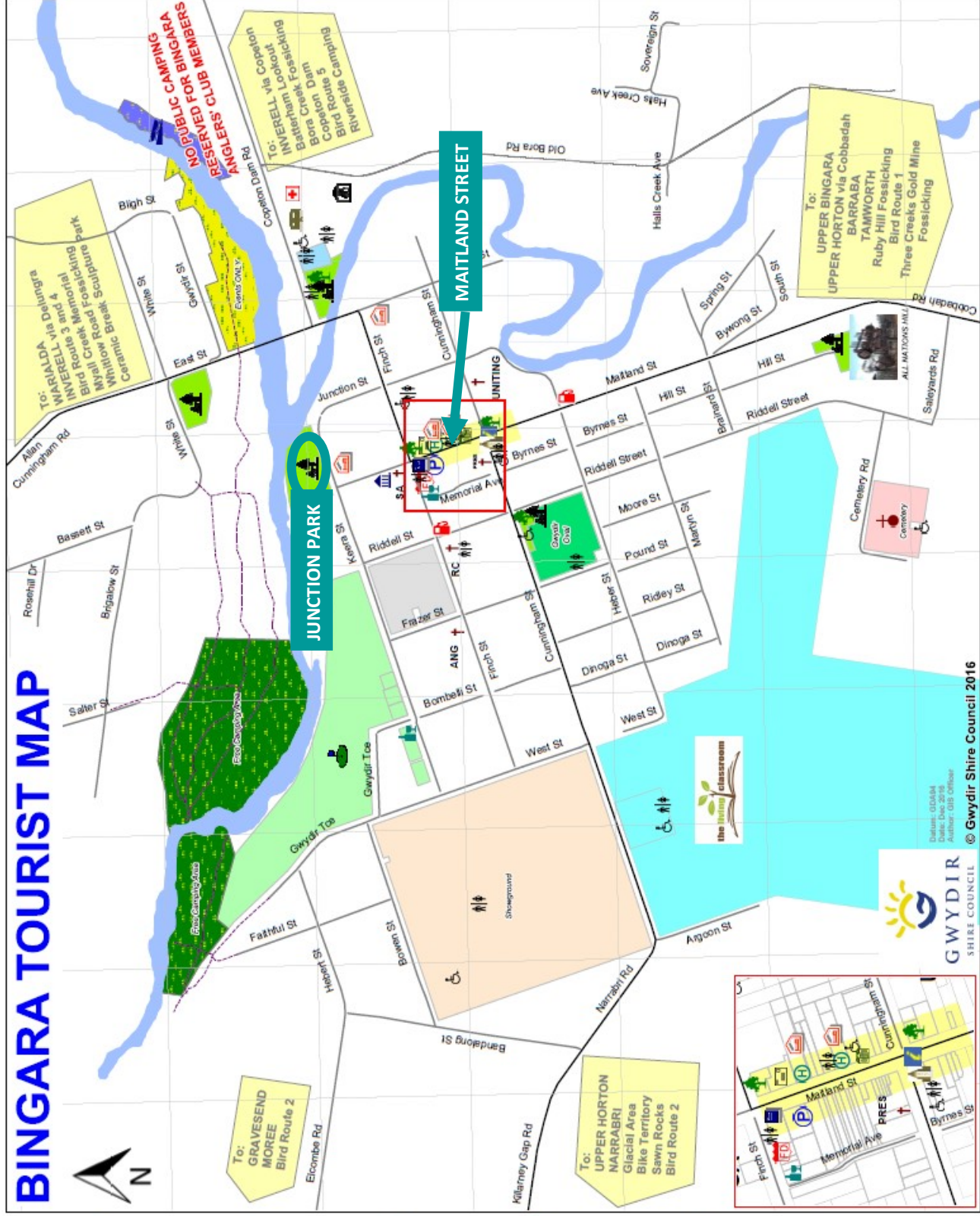
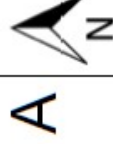
