## **BACKGROUND**

The Monthly Technical Services report has been identified by Council as the process of reporting the activities carried out monthly by the Technical Services Department.

#### COMMENT

## **IB Bore Road Upgrade**

Works continue on the SR9 IB Bore Road upgrade near North Star this month. This project is jointly funded by the Fixing Country Roads Program (\$9.54m), and the Federal Government's Heavy Vehicle Safety and Productivity Program (\$2m).

Over half of the project's length, approximately 11.5 kilometers, has been completed. The team continue with the next section, approximately 11.5 kilometers from the intersection of Croppa Creek Road and IB Bore Road, where they have completed 3km of earthworks.

#### **County Boundary Road Upgrade**

The County Boundary Road sealing project is jointly funded by the Federal Government's Roads of Strategic Importance (ROSI) Program (\$9.75 million) with Council contributing an additional \$2.44 million.

Council staff have completed Stage 1 of the construction and sealing of County Boundary Road with the initial seal carried out by contractors on 30 November 2023.

The second 3 km long stage is currently under construction. Work was temporarily stopped to allow staff to complete a 3.5km super patch trial adjacent to the project on Croppa Moree Road.Lime stabilisation of the subgrade is now programmed to start on 25 March 2024. It is expected that the 12.3 km long project will be completed by April 2025.

## **Gulf Creek Road Timber Bridge Replacement**

This project is funded by the Fixing Country Bridges Program (\$252,500) with a cocontribution from Council (\$30,000). Project planning and procurement have been completed.

The drainage works have been completed marking a significant milestone of the project. The base layer for the road has been laid down, and the table drains have been formed successfully. The next phase of the project involves sealing this section of the road to be undertaken by middle of March and installing guardrails.

## **Wearnes Road Sealing**

In February, works continued on the Wearnes Road Sealing project. This project is jointly funded under round 4 of the Fixing Local Roads program (\$2,845,929) and Council (\$256,133.61).

Polycom stabilising is complete for stage 2 of the project and underway for stage 3. 4.7km of the road has been reconstructed and sealed, with a further 5km is programmed to be sealed in early March.

## **Kerb and Gutter Maintenance**

Concreting contractors continue this month with kerb and gutter replacement works. The program will see them complete works at the new Plunkett Street units by the end of this month and Heber, Frazer, Ridley and Maitland Streets in Bingara. It is expected that the contracted crew will finish up works by the end of March 2024.

#### Maintenance

General maintenance continues on Regional and State roads, including vegetation control, slashing, whipper snipping and spraying of guideposts and guard rails and sign maintenance.

Seal maintenance is ongoing on all State, Regional and Local Roads as potholes continue to develop. Maintenance crews have installed NBN conduit for the new buildings along Plunkett Street, Warialda and backfilled for kerb.

Street sweeping has also been carried out this month. Crews have also been busy helping with drainage pipes on County Boundary Road Construction, IB Bore Road Construction and repairs to drainage pipes along Allandale Road.

Heavy Patching crews have completed a 700m section on Gwydir Highway and have moved south of Bingara with sections to be completed.

Throughout February, Flood damage crews have completed work on repairs to 2.8km of SR66 Reserve Creek Road, 12km of Glenesk Road. Crews are currently working on the last 2km of damages on SR38 Adam Scrub Road and resheeting and formation grading/ drainage works on a 1.6km section of SR81 Langley Road.

## Roads Maintenance Council Contract – Works Orders issued by TfNSW

All Work Orders issued by Transport for New South Wales (TfNSW) are quality assurance schedule of rates projects carried out by Council staff under the Roads Maintenance Council Contract with TfNSW.

The 'Hollymount' Rehabilitation Project, segment 6120 on MR63 Fossickers Way continues again this month, currently cleaning up major storm damage and retrieving lost materials, after receiving 120mm of rain in a single downpour. The crew have all steel work completed for the eastern wingwall and are now ready to transfer formwork from the western wingwall to the eastern wingwall, once sediment and erosion controls have been reinstalled and the work area desilted. Heavy patching also continues this month with the crew currently working on MR63 Fossickers Way, completing patches within reseal segments, so that the reseal program can be completed prior to colder conditions. The reseal program will be completed in conjunction with the patches being sealed as the program progresses.

Routine maintenance continues each week undertaking inspections, rest area services, vegetation control and bitumen repairs.

## **Asset Protection Zone Maintenance**

Regular slashing work is being undertaken on the Warialda APZ with another round programmed for the end of February 2024.

### **TfNSW Natural Disaster Claims**

Works are underway on flood damage repairs and are progressing well. Staff have completed all emergency works from the latest event and repair works estimates for the final suite of claims from event AGRN 1034 are almost complete. It is expected that the final claim for funding will exceed \$10 million which brings the total expected claimable flood damage costs since December 21 to more than \$25 million. Currently there has been over \$18 million in flood damage claims approved by TfNSW.

## **Local Emergency Management Committee**

The LEMC had a regular quarterly meeting in February that was well attended.

NSW Fire and Rescue advised the meeting that two new members for Bingara have been approved and booked into training and a third is currently being recruited. This is beginning to address a long running problem with the shortage of firefighters in Bingara. The SES also advised that there are now 2 members in Warialda that are booked into training. This has similarly been a long road to recruit new members and the SES have been very active in Warialda with several community engagement events in recent months.
