Issue of an access code for the North Star Transfer Station & Croppa Creek Landfill Waste Facility is dependent on the ongoing adherence with the Terms of Use Agreement.

## **General Conditions**

- 1. To not share or give out the access code to persons that do not reside at the property.
- 2. Only disposing of waste from the property nominated in this agreement.
- 3. Sorting and depositing waste into the designated signed areas at the landfill site
- 4. No commercial waste.
- 5. No asbestos (Disposal available at Warialda and Bingara Landfills).
- **6.** No chemical waste (Dispose at Household Chemical collection events at Warialda and Bingara Landfills).
- **7.** No bulky items at North Star Transfer Station. Bulky items must be taken to Croppa Creek Landfill.
- **8.** DrumMuster available at Croppa Creek, Warialda and Bingara Landfills. (Bookings essential see: <u>https://www.agsafe.org.au/dm-collection-sites</u>.)
- 9. No liquid waste.
- **10.** No petroleum or oil products (Disposal available at Warialda and Bingara Landfills).
- **11.** Placing waste items as far back into the areas as practicable to maximise the available space at the site.
- **12.** No scavenging.
- 13. Access during daylight hours only.
- 14. Advising Council of any issues at the Landfill site.
- **15.** Follow directions on signage at the site.
- **16.** Follow directions given by staff on the site.
- 17. No smoking, naked flames, or lighting fires.
- **18.** I understand that the facility is under CCTV surveillance.
- 19. Advise Council if you are moving or renting your property.
- **20.** Ensure the chain on the gate is placed back in its original location and the lock is securely closed. The lock will automatically re-engage.

## **Rental Properties**

1. I will inform the council when a tenant leaves, and a new code will be issued.
